

Senator Dave Cortese was elected in November of 2020 to represent State Senate District 15 which encompasses much of Santa Clara County in the heart of Silicon Valley. Along with his accomplished career as an attorney and business owner, the Senator previously served on the Santa Clara County Board of Supervisors for over a decade, with four years as Board President, on the San Jose City Council for eight years, including two years as Vice Mayor, and as a trustee for the East Side Union High School District for eight years.

He grew up in San Jose as part of a family that has been active in civic, cultural, and business activities for generations. Dave graduated from Bellarmine College Preparatory then University of California, Davis where he earned a Bachelor of Science Degree in Political Science. He earned his Juris Doctorate at Lincoln University Law School in San Jose. He has four children and is married to his wife Pattie Cortese who is currently a Trustee on the Eastside Union High School Board.



Anna G. Eshoo Honored Keynote Speaker Like the Silicon Valley region she represents, Congresswoman Anna G. Eshoo exemplifies innovation. She's creative, productive, a problem solver and a consensus builder. For over two decades in Congress, Rep. Eshoo has defended consumers, promoted American competitiveness and innovation, fought for access to health care for families and children, protected the environment, and encouraged development of clean energy technology.

Committee Leadership Roles

On January 15, 2019, the Democratic Members of the House Energy and Commerce Committee voted to elect Congresswoman Eshoo as the first woman ever to serve as Chair of the Health Subcommittee. Rep. Eshoo has served on the powerful House Energy and Commerce Committee since 1995, and she previously served as the Ranking Member of the Subcommittee on Communications and Technology for six years, the first woman in the history of the Subcommittee to serve in a leadership role.

Rep. Eshoo was born in New Britain, Connecticut, of Assyrian and Armenian heritage. She is the proud mother of two children, Karen and Paul.

Eshoo is a graduate of Cañada College and the CORO Foundation and was awarded an Honorary Degree by Menlo College. She was elected to the San Mateo County Board of Supervisors in 1982 and served on the County Board for ten years before being elected to the U.S. House of Representatives in 1992.
